<b>Features</b> On Dec. 17, 1999, P.L. 106-170 reauthorized the WOTC and Welfare-to-Work tax credits through Dec 31, 2001 to encourage employers to hire 9 groups of job seekers with barriers to employment.

- ◆ **Employers:** Contact your Regional WOTC/WtW Coordinator to learn how you can earn *federal income tax savings of up to \$8,500 for each new hire.*
- ◆ **Economic and Community Development Agencies:** Contact your Regional WOTC/WtW Coordinator to learn how you can help business in your area benefit from these tax savings.
- ◆ **Social Service Delivery and Workforce Development Agencies:** Contact your Regional WOTC/WtW Coordinator to learn how you can help your customers gain a competitive edge in the job market by qualifying their prospective employers for these federal tax credits.
