**Trade Adjustment Assistance Community College and Career Training (TAACCCT)
Grants Program**

AGENCY: Employment and Training Administration, Department of Labor

ACTION: Amendment to SGA/DFA PY 12-10

SUMMARY: The Employment and Training Administration announced on April 19, 2013 the availability of funds and Solicitation for Grant Applications (SGA) for Trade Adjustment Assistance Community College and Career Training grants to be awarded through a competitive process.

This amendment to the SGA revises Section I.B.3, encouraging applicants to reference the apprenticeship framework, as the apprenticeship consortium is still in development; amends language in Sections III.D.1.b, IV.B.4 and Appendices K and M; provides links to the Prospective Applicant webinars and Frequently Asked Questions (FAQs); and announces the TAACCCT Online Panel Discussion. The document is hereby amended as follows:

Section I.B.3. Core Element 3: Transferability and Articulation of Credit (new language in bold)

OLD TEXT:

The Department is interested in the transferability and articulation of academic credit that will create career pathways for TAA-eligible workers and other adults to further their education. TAACCCT programs may accomplish this through increased cooperation among institutions within and across state lines, as well as through linkages with programs, such as postsecondary career and technical education, pre-apprenticeship and apprenticeship programs, and other programs that lead to credit-bearing coursework and employment. In the case of awarding credit for completion of apprenticeship programs, applicants are encouraged to work with the Registered Apprenticeship Community College Consortium to develop credit recommendations and articulation agreements. NEW TEXT:

The Department is interested in the transferability and articulation of academic credit that will create career pathways for TAA-eligible workers and other adults to further their education. TAACCCT programs may accomplish this through increased cooperation among institutions within and across state lines, as well as through linkages with programs, such as postsecondary career and technical education, pre-apprenticeship and apprenticeship programs, and other programs that lead to credit-bearing coursework and employment. **In the case of awarding college credit for completion of apprenticeship programs, applicants are encouraged to refer to the Registered Apprenticeship College Consortium Articulation Framework for an**

example of criteria that may be used to develop credit recommendations and articulation agreements. Section III.D.1.b. Performance Metrics of the Scorecard (new language in bold)

OLD TEXT:

Although the set of metrics proposed must include the six items listed below, the Department encourages applicants to propose metrics in addition to those listed below, where appropriate, and the appropriate length of time of measurement.

NEW TEXT:

Although the set of metrics proposed must include the **five** items listed below, the Department encourages applicants to propose metrics in addition to those listed below, where appropriate, and the appropriate length of time of measurement.

Section IV.B.4. Pre-Conditions Documentation Attachments; and Appendices K and M (new language in bold)

In all instances where the SGA refers to “Labor Market Information (LMI) attachment,” the text is changed to “**Two-page** attachment.”
