**QUESTIONS NEEDING CLARIFICATION**

- 1. Page 8 Non-Res-“ will come from 15 mile radius of center”- why 15 miles?**

**Response: The 15 mile radius for non-residential students attending the Mississippi Job Corps Center has been extended to a 30 mile radius.**

- 2. Page 12 ESL- Not applicable –But, last sentence indicates it is applicable for 74 students.**

**Response: ESL is not applicable to the Mississippi Job Corps Center. The last sentence on page 12 section C item 12 which reads “The ESL program at this center is Spanish and currently consists of 74 students” is eliminated.**

- 3. Page 15 Post-Center Transition reference to Homestead Job Corps Center.**

**Response: Page 15 Section D. Career Transition Services the item that reads “enrolled at Homestead Job Corps Center” is corrected to read enrolled at Mississippi Job Corps Center.**

- 4. Comment - Staffing Chart Job Titles should be updated to reflect changes in Job Corps. Residential Living Director**

**Response: The contractor responding to the RFP has the option of renaming titles listed on the staffing chart by placing the new/updated title in parenthesis beside the historically used title until such time the standard RFP reflects new titles used in Job Corps.**

- 5. Page 78 Day instructional Staff - “roughly 28% of students are full time in vocational” How was this determined?**

**Response: The 28% of students who are in full time vocational training was determined by the On Board Strength and the number of those students who are scheduled full time into the vocational training program.**
