Section L.5 Submission of Proposals C. Specific Instructions – Step 2: Oral Presentation

First Paragraph is deleted and changed as follows:

Only those offerors determined to be within the competitive range will be requested to make an oral presentation as part of the oral discussion process and in accordance with the procedures detailed below. The anticipated dates for oral presentations/discussions to begin during the week of **June 23, 2003**. Offerors within the competitive range will be notified no later than 3 weeks prior to the dates scheduled for oral presentations.

Section L.5 Submission of Proposals C. Specific Instructions – Step 2: Oral Presentation

Paragraph 2) b) is deleted and changed as follows:

b) Scheduling

Once the Contracting Officer has set the competitive range, each offeror within the range will be provided a date, time and location for their oral discussions that shall include the oral presentation to be given to the Government. The order in which offerors will make their presentations will be determined by drawing of lots. Once notified, the offeror must make its presentation at the required date and time. Requests to be rescheduled will not be entertained unless exigencies make the attendance of the offeror virtually impossible. The Government retains the sole right to reschedule oral discussions and presentations. The anticipated date for oral discussions/presentations to begin is the week of **June 23, 2003**.
