

SUBJECT : Revised Welfare-to-Work Financial and Participant Reporting

1. Purpose. To transmit a revised Welfare-to-Work (WtW) financial and participant reporting format and corresponding revised instructions for WtW formula grantees.

3. Background. The 1999 Amendments made several changes to WtW Program, including the elimination of the participant and financial reporting requirements as originally enacted. The 1999 Amendments authorized the Secretary of Labor, in consultation with the Secretary of Health and Human Services as well as States, organizations representing States, and localities, to establish requirements for the collection and maintenance of financial and participant information and the reporting of such information. The reporting format and instructions transmitted in TEGL No. 11-97, Change 1, have thus been revised to conform with the financial and participant changes authorized under the 1999 Amendments.

4. Specific Revisions. The following changes have been made to the WtW Formula Grant Cumulative Quarterly Financial and Participant Status Report.

- < The “Federal Expenditures by Activity” section has been deleted, and has been replaced by line 7, “Federal Program Expenditures.”
- < New line items have been created to capture data on the new eligibility categories created by the 1999 Amendments. These lines items are:
 - < 24(a): general eligibles/noncustodial parents
 - < 24(a)(1): long-Term Temporary Assistance for Needy Families (TANF) recipients and exhaustees
 - < 24(a)(2): noncustodial parents
 - < 24(b): other eligibles
 - < 24(b)(1): TANF recipients with characteristics of long-term welfare dependence or barriers to self-sufficiency
 - < 24(b)(2): former foster care participants
 - < 24(b)(3): custodial parents with incomes below 100% of poverty

Please note: Entries for items 24(a) and 24(b) should represent the cumulative aggregate number of all participants served in the general eligibility/noncustodial parents and other eligibles eligibility categories, respectively, since the inception of the grant. Therefore, item 24 should be the sum of items 24(a) and 24(b). Entries for items 24(a)(1) and 24(a)(2), and entries for items 24(b)(1) through 24(b)(3), should represent the cumulative aggregate number of all participants enrolled in the eligibility subcategories under the general eligibility/noncustodial parents and other eligibles eligibility categories, respectively, since the effective date of the 1999 Amendments (July 1, 2000). We are applying these new reporting elements retroactive to the effective date of the 1999 Amendments, not retroactive to the inception of the grant. Please review the reporting instructions for additional information.

- < New line items have been created to capture basic participant demographic information. These line items are: 31 and subparts (gender), 32 and subparts (age), 33 and subparts (race and ethnicity), and 34 (participant-volunteered disability). *Please note:* Entries for Items 31 through 34 should represent the cumulative aggregate number of all participants enrolled in these categories since the effective date of the 1999 Amendments (July 1, 2000). We are applying these new reporting elements retroactive to the effective date of the 1999 Amendments, not retroactive to the inception of the grant. Please review the reporting instructions for additional information.
- < The revised reporting instructions clarify that the earnings gained and retention line items are cumulative. *Grantees who have not been reporting cumulatively on these line items in the past must cumulate all previously-submitted data and must enter cumulative data for these line items on the report for the quarter ending June 30, 2001.*
- < The revised reporting instructions clarify reporting on the placement line items (lines 26, 27, 28, and their subparts), and clarify the use of alternate data sources for reporting on the retention and earnings gained items (lines 29, 30(a) and 30(b)).

5. Action Required. The State is required to report on the revised format beginning with the quarter ending June 30, 2001 (April 1, 2001 - June 30, 2001). The first report on the revised format is, therefore, due in the Employment and Training Administration no later than August 15, 2001. The State is reminded to have the designated official within the organization review the data for accuracy and completeness prior to entering the Password and Personal Identification Number (PIN). This official is also responsible for timely submission of the data.
