## State Economic Activity

For the second consecutive year, the change in West Virginia's total nonfarm payroll employment was essentially flat, with a loss of less than one-half of one percent (0.4 and 3,300 jobs). Similarly, individuals in the labor force who were employed or actively seeking employment declined 9,600 between 2013 and 2014. The number of unemployed fell 2,500 in the twelve-month review, rendering an unemployment rate of 6.5 percent. Compared to the 2013 unemployment rate, this represents a drop of 0.2 percent.

Over-the-year jobs losses for West Virginia totaled 3,300, with goods-producing industries responsible for the majority (3,000). Service-providing businesses had virtually no change in the twelve-month review, declining by only 300. Goods producing losses included mining and logging (-1,400), construction (-1,000), and manufacturing (-600). Only two service-providing sectors gained employment over the year: professional and business services (+1,900), and educational and health services (+300). Losses were recorded in trade, transportation, and utilities (-900), financial activities (-100), leisure and hospitality (-800), other services (-400), and government (-200).

There was modest improvement in county unemployment rates between 2013 and 2014. In 2013, nine-teen counties recorded unemployment rates that were lower than the state annual rate of 6.7 percent. In 2014, however, the number of counties posting unemployment rates lower than the state rate of 6.5 percent grew to 21. Of the thirty-four counties with rates higher than the state rate, seven had rates that increased in the twelve-month interim. Those counties include Marshall (7.4% to 7.6%), Tyler (8.5% to 8.9%), Wyoming (9.2% to 9.4%), Wetzel (9.2% to 10.3%), Logan (9.7% to 10.3%), Mingo (11.2% to 11.8%), and McDowell (12.5% to 12.9%). Not unexpectedly, the lowest unemployment rate for the year was recorded by Monongalia County (4.4%). Monongalia was joined by Doddridge (4.9%), Pendleton (4.7%), and Jefferson (4.5%) as the only counties whose rates were less than 5 percent.

Unemployment in the workforce investment areas generally improved between 2013 and 2014. The exceptions were Workforce Investment Areas 3 and 5 whose rates remained the same over the year. Workforce Investment Areas 6 and 7 posted the lowest unemployment rate (5.6%) in the comparison, followed by Workforce Investment Area 3 (5.9%), Workforce Investment Area 2 (6.5%), Workforce Investment Area 4 (7.2%), Workforce Investment Area 5 (7.3%), and Workforce Investment Area 1 (7.9%).

For the third consecutive year, average annual employment measured by the Quarterly Census of Employment and Wages (QCEW) declined. Employment fell a negligible 0.3 percent (-1,900) from the 2013 level of 703,717 to 701,817 in 2014. Losses were posted in natural resources and mining (-1,834), construction (-463), manufacturing (-578), trade, transportation, and utilities (-224), financial activities (-77), leisure and hospitality (-141), and government (-1,286). Employment gains included information (+87), professional and business services (+2,161), education and health services (+340), and other services (+487). West Virginia workers experienced a reasonable increase in wages of \$894 (2.2%) from a level of \$40,199 in 2013 to \$41,093 in 2014. This increase exceeded the 1.5 percent increase achieved across the United States according to the U.S. Bureau of Labor Statistics and their consumer price index for urban wage earners (CPI-W).

West Virginia's per capita personal income improved a modest \$393 (1.1%) during 2013. Per capita personal income in the state stood at \$35,140 in 2012 and grew to \$35,533 over the year. The U.S. income for the same period performed only slightly better increasing \$565 (1.3%) to \$44,765. Of the state's fifty-five counties, twelve produced per capita personal income exceeding the statewide average in 2013. Those counties include Pleasants (\$35,652), Cabell (\$35,779), Lewis (\$38,491), Marion (\$39,249), Raleigh (\$39,293), Monongalia (\$39,550), Jefferson (\$39,939), Ohio (\$40,397), Marshall (\$42,016), Putnam (\$42,903), Harrison (\$43,120), and Kanawha (\$44,817). Kanawha was the only county in West Virginia with per capita personal income that surpassed the national level of \$44,765.

The West Virginia 2014 estimate of population provided by the U.S. Census Bureau indicates the state was home to 1,850,326 inhabitants. This represents a decline of 3,269 residents over the year, or 0.2 percent. Of the fifty-five counties, Berkeley County's population expanded the most by adding 1,813 (+1.7%), followed by Monongalia (1,246, +1.2%), Jefferson (752, +1.4%), Putnam (184, +0.3%), and Tyler (100, +1.1%). Kanawha County suffered the largest decline in population, losing 1,171 residents. Rounding out the bottom five were Logan (-633, -1.8%), McDowell (-442, -2.1%), Fayette (-435, -1.0%), and Wayne (-403, -1.0%).

While the national economy continues to record notable month to month job gains and project an overall healthy outlook, the West Virginia economy appears to be stuck in a slower gear. Statewide job gains have been less noteworthy and confined to a select few industry sectors. In particular, industries the statewide economy relies on so deeply for economic well-being have been suffering most. The hardships and misfortunes of the coal industry, for example, have been clearly detailed. Older coal-fired power plants across the nation and around the world are being phased out, in favor of plants utilizing less expensive and plentiful natural gas for electrical generation. As a result, coal mining employment and its economic influence on the state continues to wane. The optimistic note in this data is the abundance of natural gas within state boundaries. Projected reserves from the Marcellus and Utica shale fields will likely keep the state involved in natural gas production for decades. The apparent downside, however, is gas production is far less labor intensive and creates significantly fewer jobs. Similarly, construction industry employment in the twelve-month interim has faltered across the state. While residential construction has seen modest job growth (1.7%), non-residential construction has experienced the opposite. Over the year job losses have exceeded five percent. Although this may not appear too severe, it is a bleak indicator for the state economy and its recovery.

There are more encouraging indicators, especially in the early part of the year ahead, that are expected to provide impetus for the construction sector and job expansion. Most notably is the non-residential construction that is expected to occur over the next two years in the eastern panhandle. Combined with the expansion of retail distribution center activities in the area, the likelihood of a turn-around for this sector becomes greater. A complete reversal of fortune for the statewide economy, however, will depend more on how quickly the private sector can take advantage of the changing energy demands of the nation and the world. Can the gas reserves within the state's borders produce a similar economic influence in West Virginia in the manner in which coal has? Or are there other energy alternatives besides natural gas that can inject life into the economy that is so far missing? The year 2008 was the first time wind energy employment surpassed coal mining employment across the nation. The 85,000 jobs this industry sustains, represents a 70% increase from the 2007 level. This sector clearly has a long way to go to attain the level of influence coal has maintained for years. Perhaps this is an opportunity to move the industry to the forefront along with other energy alternatives and enhance West Virginia's influence as an energy-producing state.

## Economic Indicators

Data from the U.S. Bureau of Economic Analysis for 2014 reveals West Virginia experienced a healthy increase in real gross domestic product (GDP). In 2014 real GDP grew by 5.1 percent, equaling Wyoming's growth and ranking both states at number three in the nation. Only North Dakota (+6.3%) and Texas (+5.2%) had a more impressive expansion. Despite setbacks in coal production, mining remains the primary impetus for GDP growth. Likewise, the natural gas industry, particularly Marcellus and Utica shale gas production, continues to make gains in its contribution to the economy. 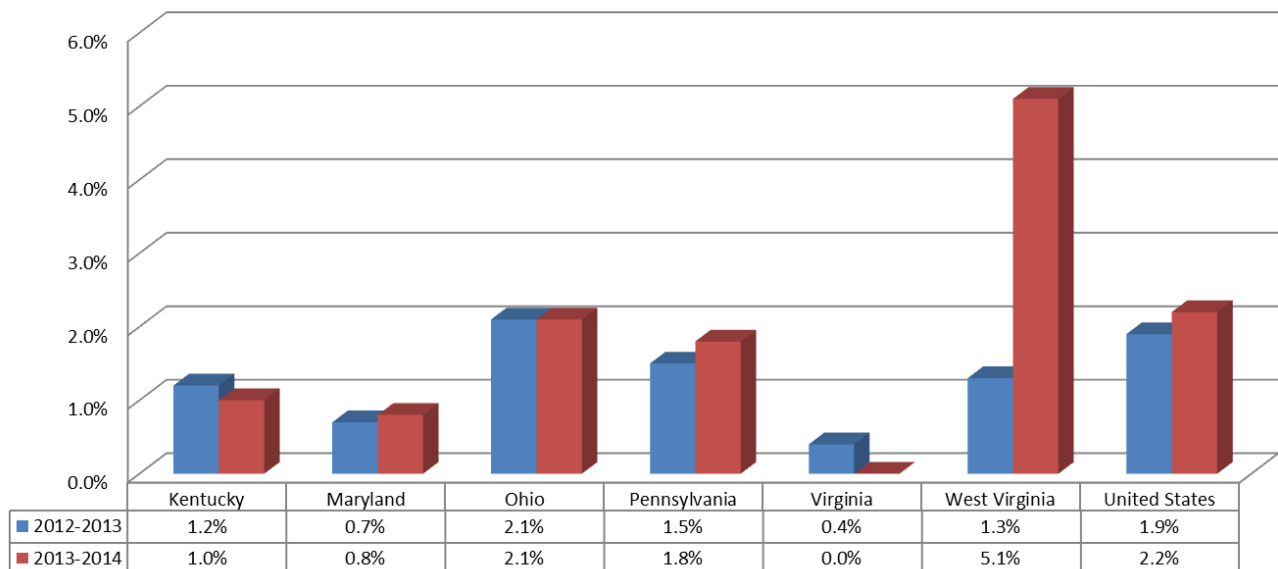

## West Virginia and its Neighbors

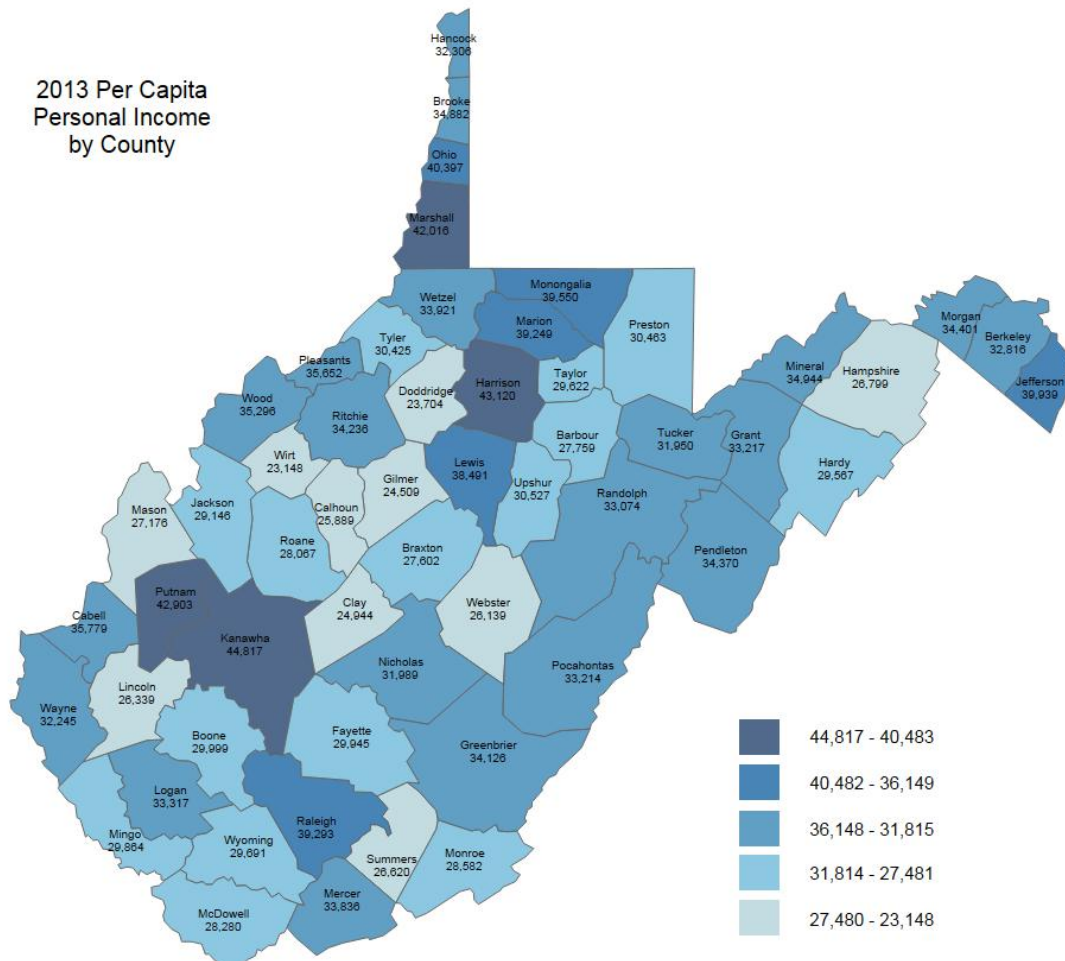
The graph below illustrates the economic disposition of real gross domestic product for West Virginia and contiguous states in 2014, and compares those national changes in GDP. With the exception of West Virginia's substantial growth in gross domestic product in 2014, the states in our region experienced little change in GDP and most are lagging behind national growth.

by County

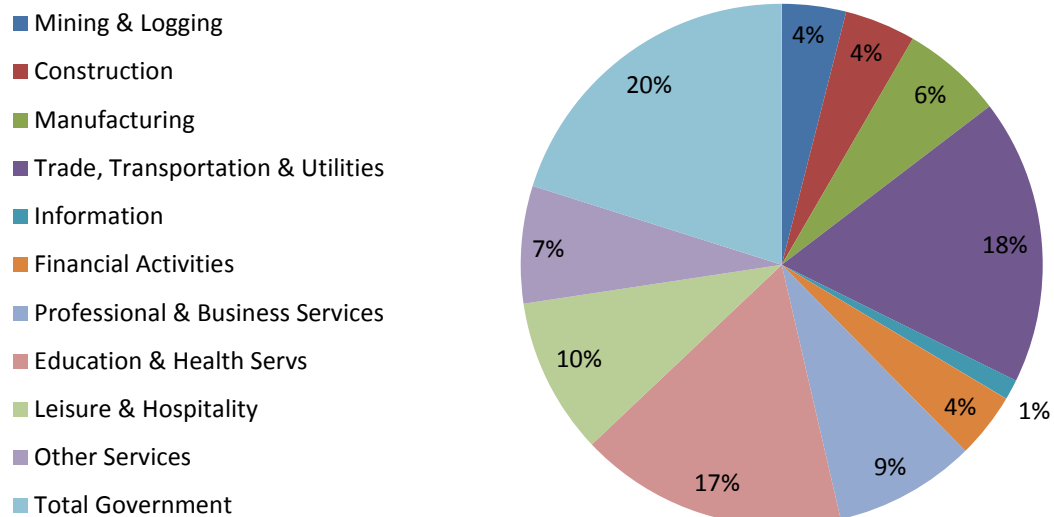


Kanawha maintained its position among all 55 counties in West Virginia as the county with the highest per capital personal income (\$44,817) in 2013. Rounding out the top ten highest incomes were Harrison (\$43,120), Putnam (\$42,903), Marshall (\$42,016), Ohio (\$40,397), Jefferson (\$39,939), Monongalia (\$39,550), Raleigh (\$39,293), Marion (\$39,249), and Lewis (\$38,491). Marshall county had the largest growth in personal per capita personal income between 2012-2013, with a growth rate of 6.8 percent. The remaining top ten with highest growth rate includes Doddridge (5.1), Ritchie (5.0), Pleasants (3.9), Calhoun (3.7), Grant (3.7), Harrison (3.6), Hardy (3.4), Hampshire (3.1), and Summers (3.0). Several counties experienced losses including Upshur (-0.1), Morgan (-0.2), Raleigh (-0.2), Fayette (-0.6), McDowell (-0.6), Berkeley (-0.7), Jefferson (-0.9), Wyoming (-0.9), Nicholas (-1.2), Logan (-1.9), and Mingo (-4.5). Statewide, a gain in per capita personal income in 2013 was 1.5 percent, below that of the U.S. rate of 2.0 percent.

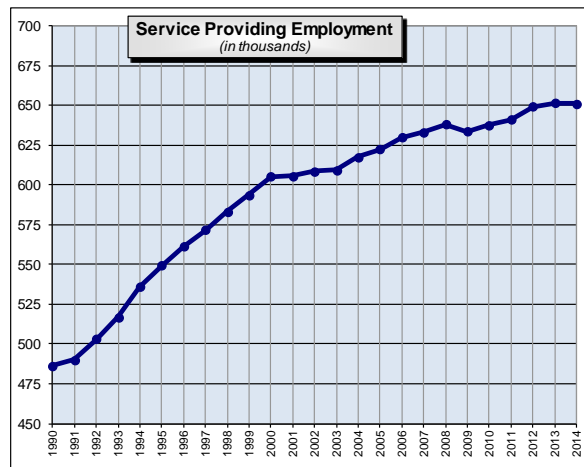
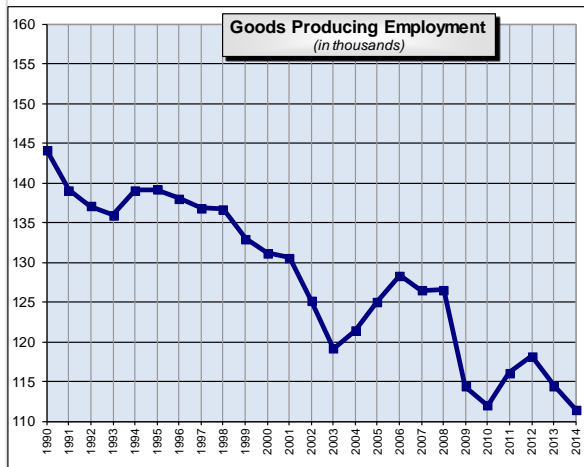
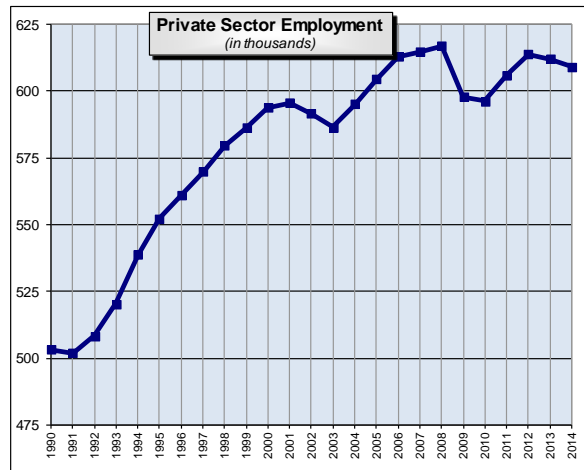
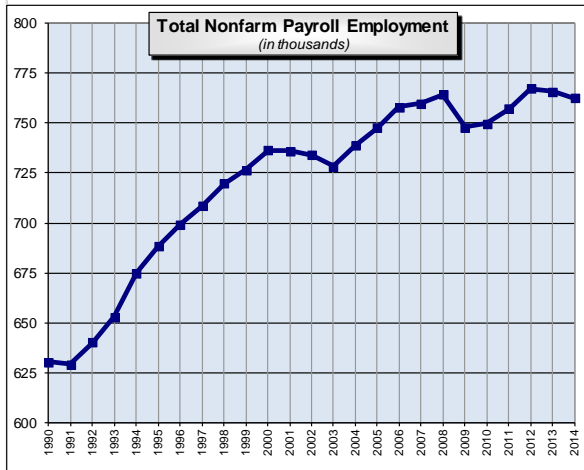
## Nonfarm Payroll Employment

In 2014, West Virginia's total, nonfarm payroll employment was dominated by government (20%), trade, transportation and utilities (18%), and education and health services (17%). The dollar value of each to the real gross domestic product (GDP) of the state according to the U.S. Bureau of Economic Analysis is 15.7% for government, 15.7% for trade, transportation and utilities, and 10% for educational and health services. In contrast, mining and logging employment provides only 4 percent of the state total. Their dollar value to the state GDP in 2014, however, is 16 percent, up from 12.3 percent in 2013. Given the consequence of a contracting coal industry, the influence of shale natural gas production across the state, which is part of the mining sector, is clearly beginning to make a difference in the transformation of the state economy.

## West Virginia Nonfarm Payroll Employment 1990 - 2014

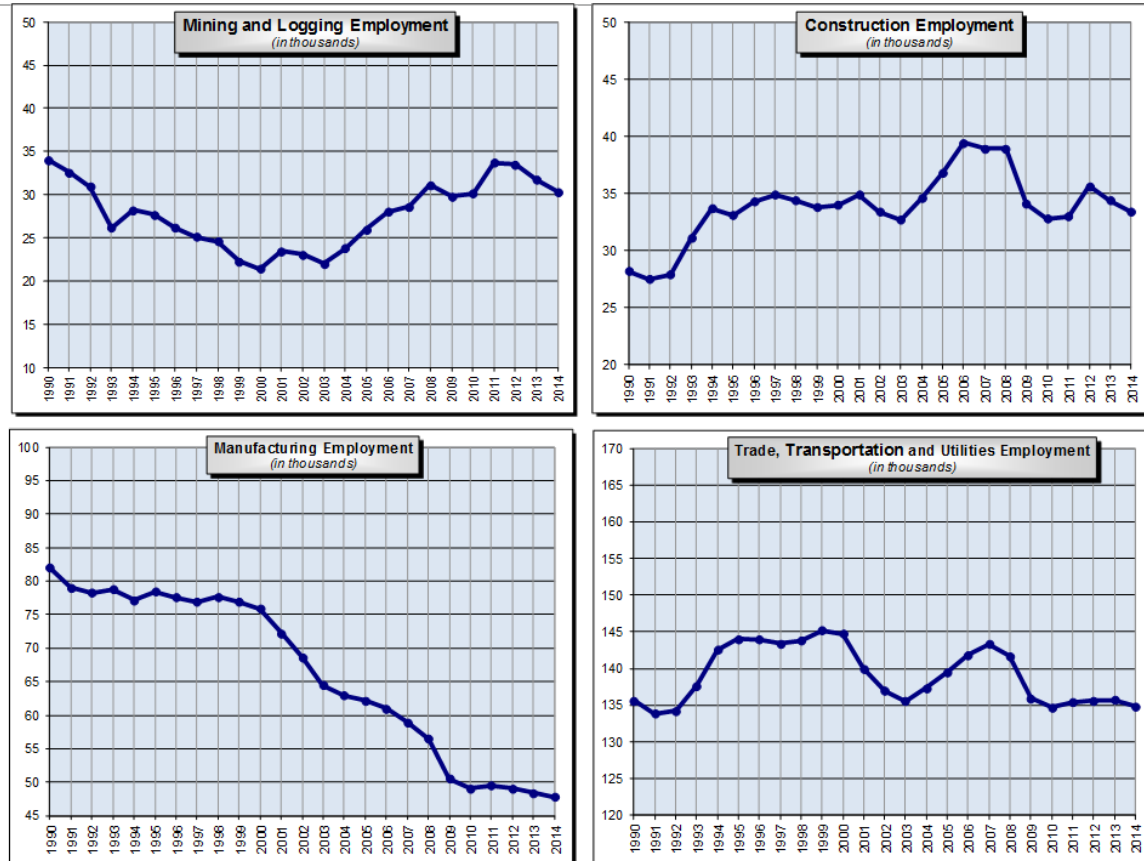

Total nonfarm payroll employment has grown from a level of more than 625,000 in 1990 to its present level of more than 762,000. What is striking in the graphs above is the complete contrast in goods-producing employment and service-providing employment. Goods-producing jobs have fallen from a level of roughly 144,000 in 1990 to 111,000 in 2014, while service providing- jobs have risen from approximately 485,000 in 1990 to 650,000 in 2014. The goods-producing sector loss is more profound, because wage rates are typically much higher than service-providing jobs. Industries in each sector have mirrored growth and declines in national nonfarm payroll employment data.



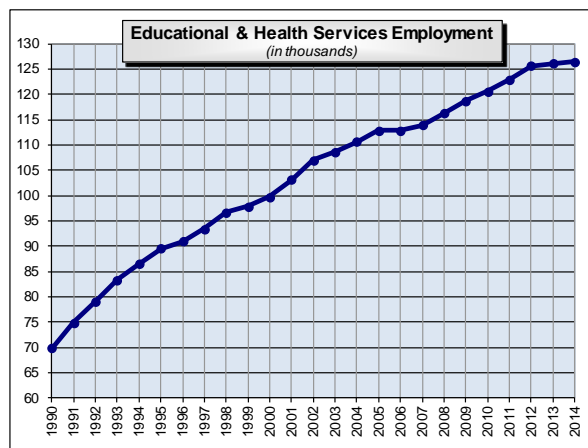
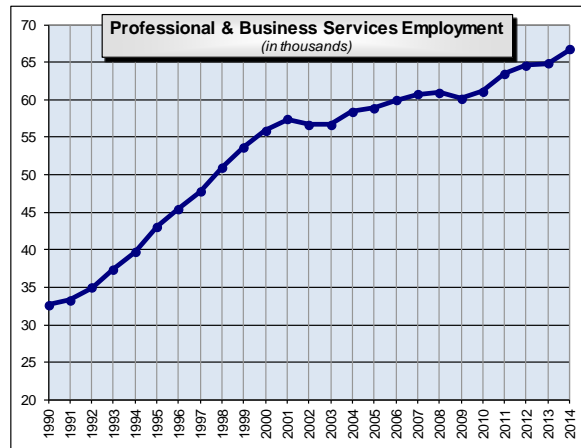
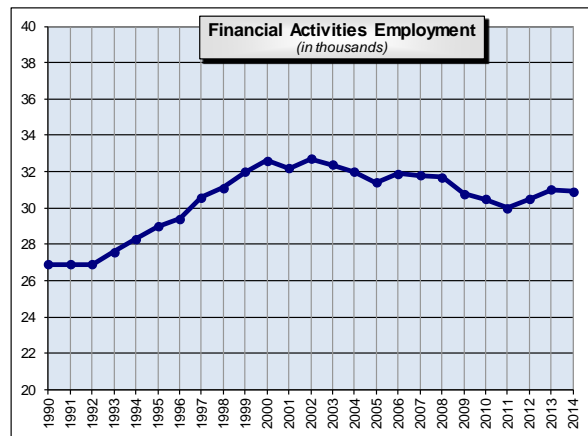
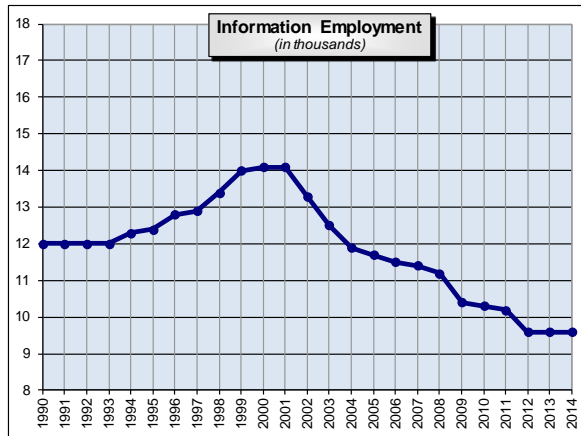
West Virginia Nonfarm Payroll Employment 1990 - 2014

Line graphs above reveal the cyclical nature of the mining and logging, construction and trade, transportation and utilities sectors. Between 2000 and 2014 West Virginia has lost nearly 40,000 manufacturing jobs, a loss especially acute due to the typically high wages.

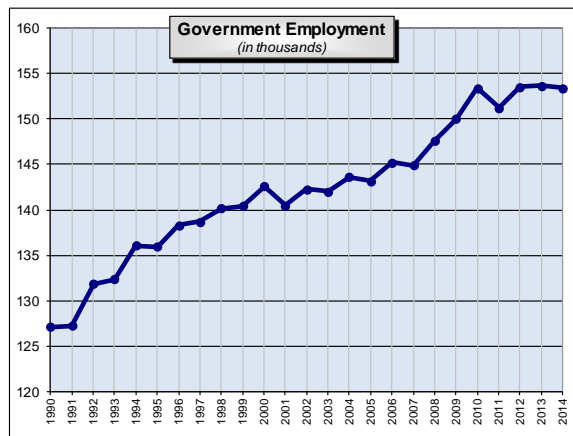
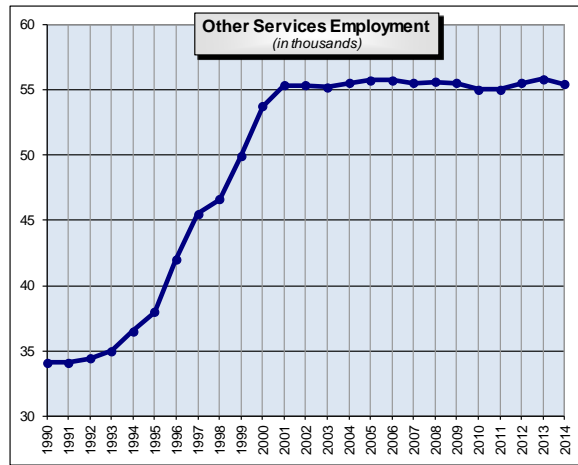
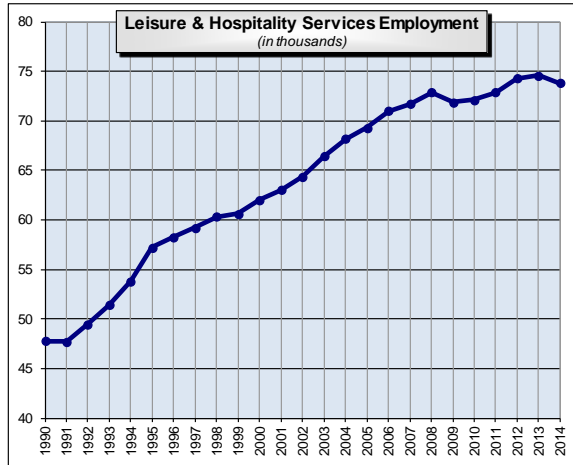
## West Virginia Nonfarm Payroll Employment 1990 - 2014



All Nonfarm Payroll Employment numbers are in thousands. Benchmark 2014

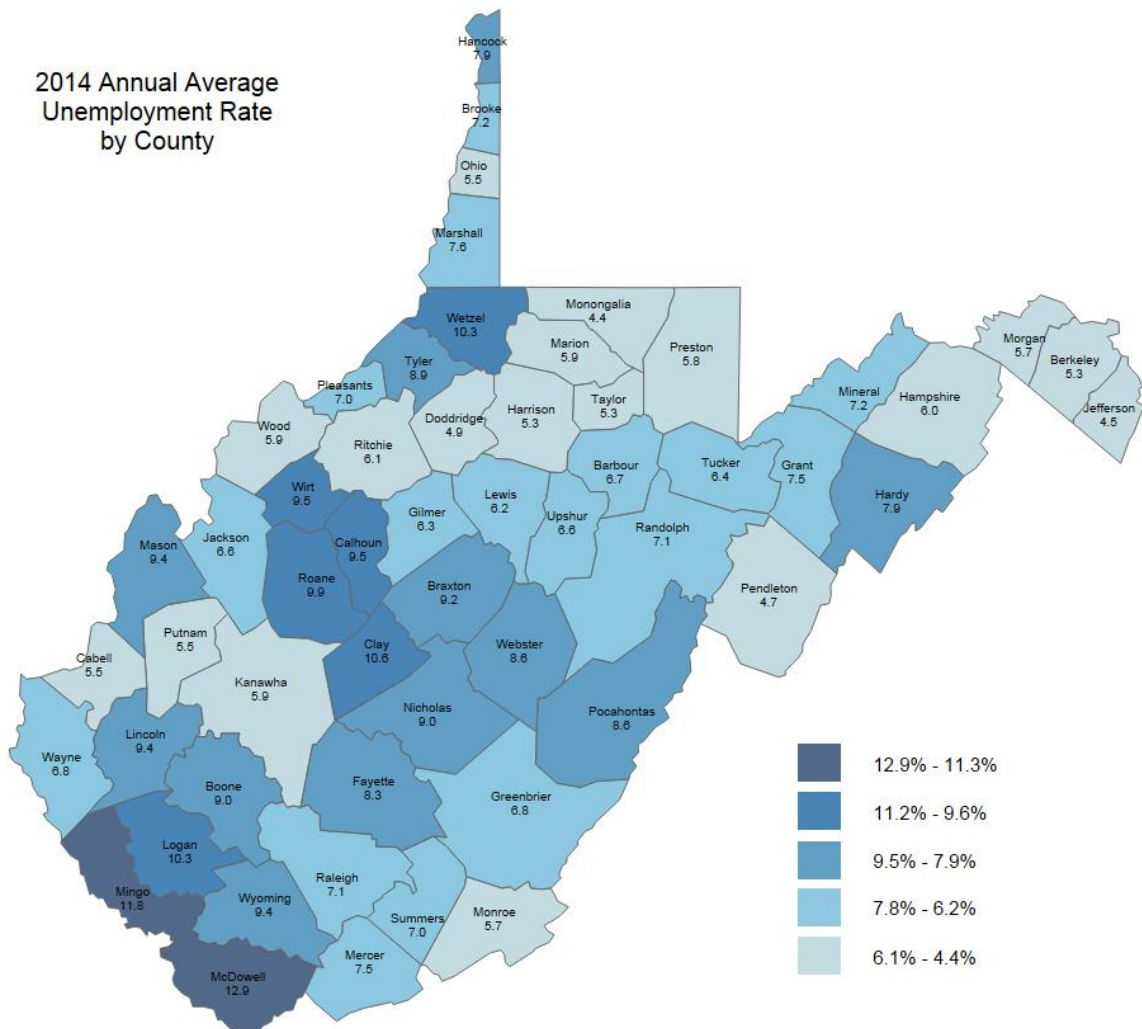
Graphs on this page indicate contrasting behavior in the information sector, modest growth in financial activities jobs, and encouraging growth in professional and business services employment. Educational and health services employment has expanded more than 80 percent from a level of 70,000 in 1990 to its present level of more than 126,000. This represents a gain of approximately 56,000 jobs. An important factor of this sector is that typical wage rates are much better than average and benefits are considerably better as well.

Graphs on this page indicate growth in both leisure and hospitality and other services employment, fueled in part by a growing tourism sector across the state. Jobs in this sector have increased from a level of more than 47,000 in 1990 to a 2014 level exceeding 73,000, a 55 percent gain. Other services, which is typically made up of small businesses, grew significantly in the 1990 to 2014 interim. Government jobs expanded as well, from a level of more than 127,000 in 1990 to 153,000 in 2014. Much of the expansion here can be attributed to growth in federal program funding.

## Civilian Labor Force



Monongalia County reported the lowest annual average unemployment rate in the state in 2014. Counties with an average annual unemployment rate below 5.0 percent in 2014 included Doddridge (4.9), Pendleton (4.7), Jefferson (4.5), and Monongalia (4.4).

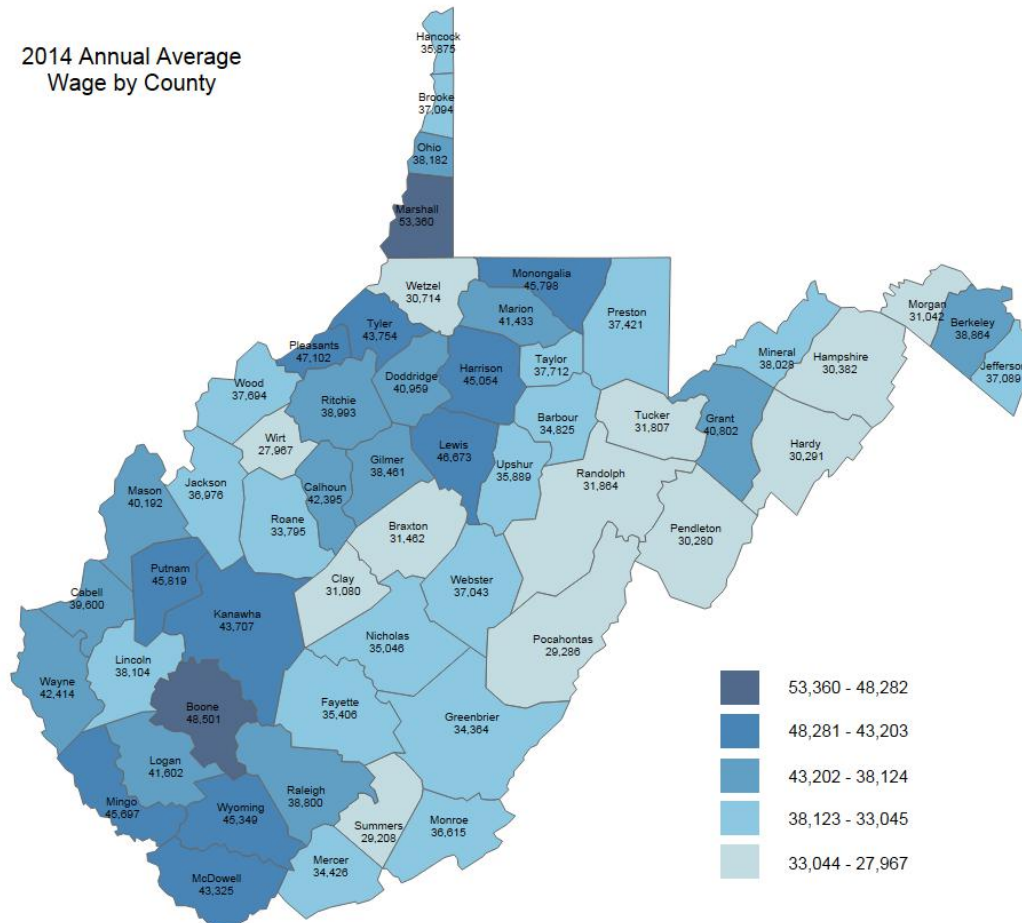
McDowell County reported the highest annual average unemployment rate in the state. Counties with annual average unemployment rates above 10 percent included Wetzel (10.3), Logan (10.3), Clay (10.6), Mingo (11.8), and McDowell (12.9).

Workers average wage in West Virginia during 2014 totaled \$41, 093. The average annual wage rose by \$894, an increase of 2.2 percent from 2013. Average annual employment decreased to 701,817 from 703,717, a decline of 1,900, or 2.7 percent. Major industry sectors that experienced employment growth included Professional and Business Services (+2,161), Other Services (+487), Educational and Health Services (+340), and Information (+87). Sectors with employment declines included Natural Resources and Mining (-1,834), Government (-1,286), Manufacturing (-578), Construction (-463), Trade, Transportation and Utilities (-224), Leisure and Hospitality (-141), and Financial Activities (-77).

Marshall County reported the highest annual average wage at \$53,360, followed by Boone \$48,502, Pleasants \$47,101, Lewis \$46,672, Putnam \$45,819, Monongalia \$45,798, Mingo \$45,679, Wyoming \$45,349, Harrison \$45,055, and Tyler 43,754. Counties with an annual average wage below \$30,000 included Pocahontas \$29,287, Summers \$29,208, and Wirt \$27,967.

The five counties with the largest growth in employment were Berkeley (+622), Harrison (+505), Preston (+452), Cabell (+384), and Tucker (+220).

Based on data that includes all worker covered by state and federal unemployment insurance programs, these statistics are updated each quarter on our website under Industry Data/Employment and Wages. A survey of wages based on four-digit NAICS codes shows Securities and Commodity Brokerage Firms (5231) paid the highest annual wage among the state's industries, with an average of \$140,004, followed by Pipeline Transportation of Natural Gas (4862) \$100,344, Electric Power Generation (2211) \$92,355, and Druggists' Goods Merchant Wholesalers (4242) \$92,230.

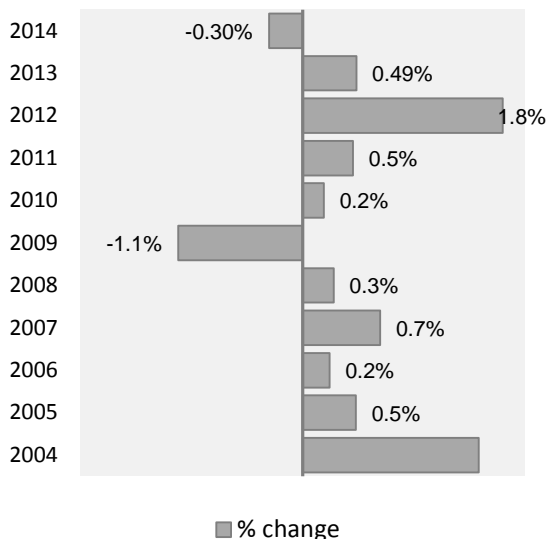

**Percent Change in Annual Average Private Sector Units**

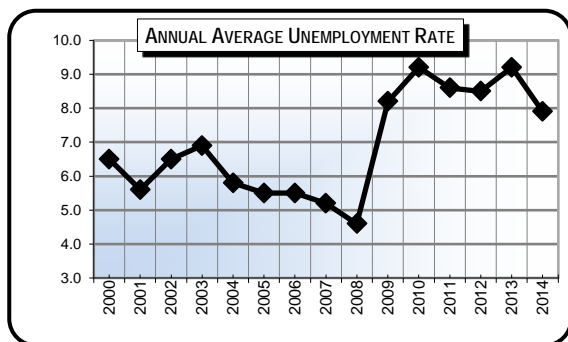
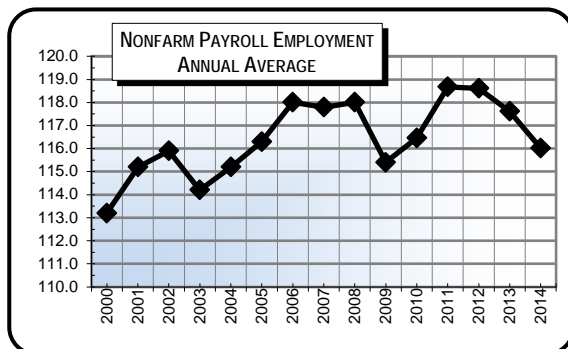
This graph illustrates the growth and decline of establishments in West Virginia between 2004-2014. The decade began with a gain of 1.6 percent, and growth remained positive through 2008. During the national recession of 2009, West Virginia lost just over 500 establishments, a decline of 1.1 percent. The years 2010 and 2011 saw a slow recovery, but the year 2012 brought the addition of just over 800 establishments, an increase of 1.8 percent, and the strongest growth in over a decade. Modest growth continued in 2013. 2014 had a slight decline of 131 establishments, a decrease of 0.3 percent.

## Endnotes

***Definitions.** GDP by state is the state counterpart of the Nation's gross domestic product (GDP), the Bureau's featured and most comprehensive measure of U.S. economic activity. GDP by state is derived as the sum of the GDP originating in all the industries in a state.*

*The statistics of real GDP by state are prepared in chained (2009) dollars. Real GDP by state is an inflation-adjusted measure of each state's gross product that is based on national prices for the goods and services produced within that state. The statistics of real GDP by state and of quantity indexes with a reference year of 2009 were derived by applying national chain-type price indexes to the current-dollar values of GDP by state for the 64 detailed NAICS-based industries for 1997 forward.*

*The chain-type index formula that is used in the national accounts is then used to calculate the values of total real GDP by state and of real GDP by state at more aggregated industry levels. Real GDP by state may reflect a substantial volume of output that is sold to other states and countries. To the extent that a state's output is produced and sold in national markets at relatively uniform prices (or sold locally at national prices), real GDP by state captures the differences across states that reflect the relative differences in the mix of goods and services that the states produce. However, real GDP by state does not capture geographic differences in the prices of goods and services that are produced and sold locally.*
