### **Name:**

The Work Opportunity Tax Credit.

### **Features:**

On December 31, 2010, the legislative authority for the two ARRA groups:  
1) Unemployed Veterans and  
2) Disconnected Youth ended.  
On December 17, 2010, P.L. 111-312 extended the WOTC Program for four additional months and HUD's-designated urban and USDA's-designated rural Empowerment Zones through December 31, 2011.

- **Employers:** Send your certification requests (IRS Form 8850 and ETA Form 9061 or 9062) to your State Workforce Agency (SWA) WOTC Coordinator.
- **Economic and Community Development Agencies:** Contact your State WOTC Coordinator to learn how you can help businesses in your area earn Federal income tax savings of up to \$9,000 per new hire.
- **Social Service Delivery and Workforce Development Agencies:** Contact your State WOTC Coordinator to learn how you can help long-term welfare recipients and 8 other target groups of job seekers gain a competitive edge in the job market by qualifying eligible participating employers for this federal tax credit.
